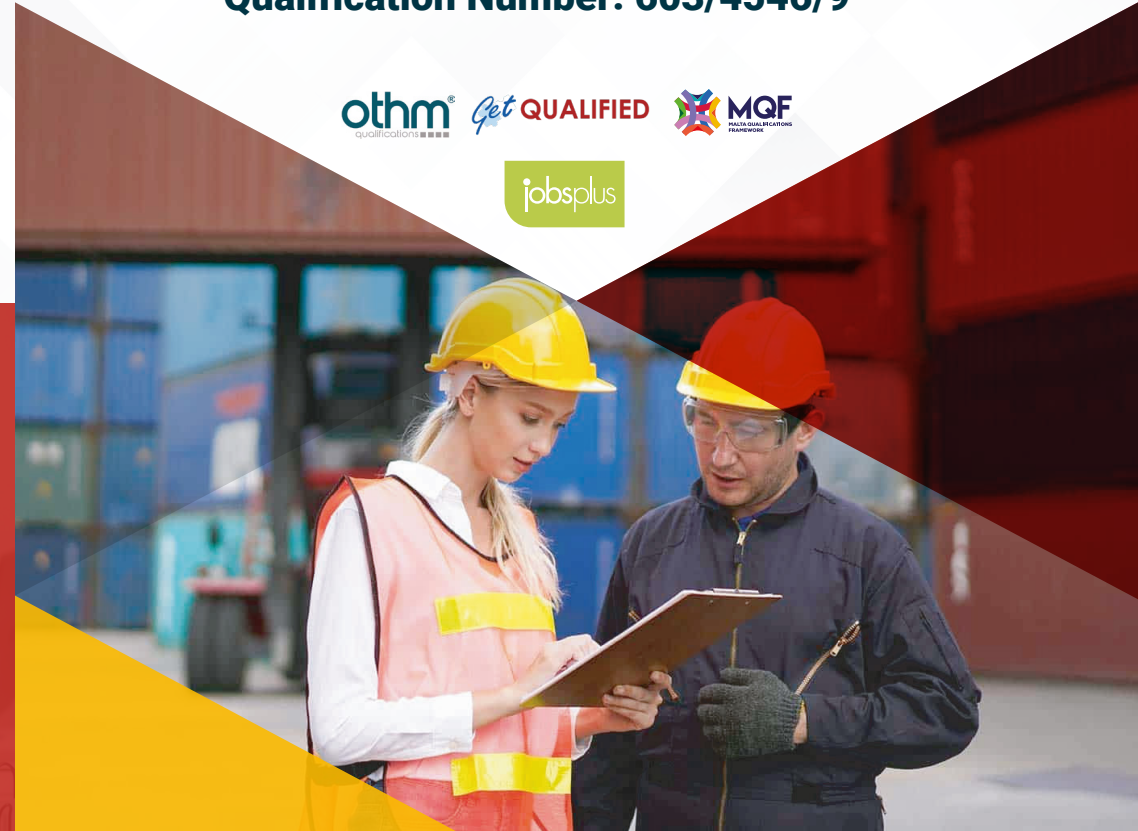

- Work in a variety of roles within logistics and supply chain management

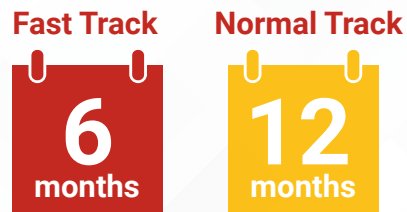

## Assessment:

Students need to achieve a 'pass' for each unit by doing an assignment of approx 2000 words to prove evidence and demonstrate fulfilment of all the learning outcomes and meet the standards specified by all assessment criteria.

## Progression routes:

Successful completion of the Level 5 Diploma in Logistics and Supply Chain Management qualification enables learners to progress into or within employment and/or continue their further study. As this qualification is approved and regulated by Ofqual (Office of the Qualifications and Examinations Regulation), learners are eligible to gain direct entry into the final year of a three-year UK Bachelor's degree.
