Overview of course:

The objective of this course ACCA (LW) is to develop knowledge and skills in the understanding of the general legal framework, and of specific legal areas relating to business, recognising the need to seek further specialist legal advice where necessary.

Courses focuses on:

- The Law of obligations (contract and Tort)
- Law relating to Employment (contract dismissal and redundancy)
- Formation and constitutions of business organisations (Agency, partnerships, corporations and formation of companies)
- Capital and the financing of companies
- Management, administration and regulation of companies
- Legal implications relating to Insolvency Law
- Develop an understanding of Corporate fraudulent and criminal behaviour (money laundering, bribery, market abuse, management fraud)
